The loess ridges provide good habitat for souslik (saker territory).

Általános célkitzések: A Natura 2000 terület természetvédelmi célkitzése az azon található, a kijelölés alapjául szolgáló fajok és élőhelytípusok kedvez természetvédelmi helyzetének megrzése, fenntartása, helyreállítása, valamint a Natura 2000 területek lehatárolásának alapjául szolgáló természeti állapot és a kedvez természetvédelmi állapottal összhangban lév gazdálkodás feltételeinek biztosítása. Specifikus célok és végrehajtandó intézkedések: - A meglév, jó állapotú gyepek jelenlegi állapotának fenntartását, valamint a degradáltabb gyepek helyreállítását célzó legeltetési/kaszálási rendszer kidolgozása, különös tekintettel a megfelelő sziki legelkre jellemz társulások rövidfűv állapotának biztosítására, és a kíméletesebb kaszálási-gyepkarbantartási rendszerek honosítására és fenntartására; - Inváziós lágyszárú növényfajok monitorozása, szükség esetén kontrollja.
